#### **Profile**

The New Zealand China Trade Association (**NZCTA**) is a bilateral business council promoting and fostering trade and other business links between New Zealand and China.

Formed in 1981, its inaugural membership comprised importers and exporters, creating a network to discuss and overcome the challenges of trading with China. Today there are numerous company and individual members representing a diversity of New Zealand business interests including seasoned traders, merchandise firms, exporters, importers, manufacturers, shipping and freight companies, banks, legal firms and other service companies both in NZ and China.

The prime objective of the Association is to build bridges and strengthen trade relations between New Zealand and China.

NZCTA enjoys the support and involvement of both governments. Representatives from MFAT, NZTE, Auckland Unlimited and the New Zealand China Council are on the NZCTA Executive Committee. We regularly engage with Chinese Government officials from the Consulate Generals in Auckland and Christchurch and the Embassy in Wellington.

We also have a number of strategic relationships with allies and partners in both New Zealand and China including the China Council for the Promotion of International Trade (CCPIT), the China Chamber of International Commerce (CCIOC), China Foreign Trade Centre, Export New Zealand, Kiwi Expats Association (KEA), North Asia CAPE and the China Chamber of Commerce in New Zealand. In 2014, NZCTA launched the NZCTA Young Associates which is geared at tertiary students and Young Professionals.
